

The powers and duties of officers and employees

For conducting anti-dumping investigation, investigating teams are formed in DGTR. The investigating team, comprising of two investigating officers (IOs) and two costing officers (COs), conducts detailed investigations in accordance with the provisions of Customs Tariffs Act, 1975, Anti-Dumping Rules, Anti Subsidy Rules under the overall supervision and control of Director General (DG).
