Subject: Regarding PCN Methodology in the Sunset Review of the anti-dumping duties in force on the imports of "Jute Products" (Jute Yarn/twine, Sacking cloth, Sacking bag and Hessian Fabric) originating in or exported from Bangladesh and Nepal.

- 1. This refers to the initiation notification dated 28th June, 2021 in the captioned/subject investigation vide which the Authority had solicited comments on PCN's from the interested parties for fair comparisions to evaluate incidence of dumping and consequential injury.
- 2. After taking note of the comments received from the interested parties thereon, the Authority proposed a PCN-methodology vide its letter dated 18th August 2021.
- 3. Comments of the interested parties on the said methodology were sought by 25 August 2021. After examining the comments by the interested parties the following PCN-methodology is being adopted by the Authority for the first product type i.e. **Jute Yarn/twine (multiple folded/cabled and single)** in the subject investigation.
