**Subject: - Final PCN methodology – Anti-dumping investigation concerning imports of “Industrial Laser Machines, used for cutting, marking, or welding” from China PR.**

1. This has reference to the initiation notification F. No. 6/7/2022-DGTR dated 29<sup>th</sup> September, 2022 *vide* which comments were invited from all interested parties on the PCNs proposed in the initiation notification. Comments received from the interested parties have been examined and the final PCN methodology adopted is mentioned as under: -

*For example, a 3D Laser Cutting Machine of bed size 3000mm x 1500mm with a MAX fibre laser with laser power of 1kW has the PCN 'CL01000B1C3Y3D'.*

2. The following are clarified with respect to the scope of the PUC:
  - a. The scope of the PUC is not limited to LCM with laser power more than 500 watt.
  - b. Industrial Laser Machines in fully assembled, SKD, and CKD forms are included within the scope of PUC. Pursuant to request by the domestic industry, 'dedicated use standalone components' are excluded from the scope of the PUC.
3. It is also informed to all interested parties that this is the final PCN notification. Further, no modification/ comments/ arguments would be entertained by the Authority regarding PCNs.
4. In view of the above, all interested parties are requested to file questionnaire responses in accordance with the above PCN-methodology latest by **28-12-2022**. No further extension of time will be granted by the Authority to file the questionnaire responses as anti-dumping investigation is time bound.
5. This issues with the approval of the Designated Authority.
