1. anti-dumping investigation concerning imports of “Ursodeoxycholic Acid (UDCA)” originating in or exported from China PR and Korea RP, was initiated on 24.01.2022 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.
