NOTICE FOR ORAL HEARING

Subject: Oral hearing in Anti-dumping investigation concerning imports of “Monoethylene glycol (MEG)” from Saudi Arabia, Kuwait and USA.

An Anti-Dumping investigation concerning imports of “Monoethylene glycol (MEG)” from Saudi Arabia, Kuwait and USA was initiated on 28th June, 2021 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.

2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, Designated Authority has scheduled an oral hearing in the matter through Digital Video Conference (DVC) to be held on **09th December, 2021 at 02: 30.hrs. (IST)**.
3. You will be required to submit written submissions and the rejoinders (confidential and non-confidential versions) of the views expressed at the hearing within the date and time schedule to be indicated on the date of hearing.
