**Subject: Rescheduled of oral Hearing of sunset review investigation concerning imports of “Cold Rolled/cold reduced flat steel products of iron or Non-Alloy Steel, or other Alloy Steel, of all width and thickness, not clad, plated or coated” originating in or exported from China PR, Japan, Korea RP and Ukraine.**

Sunset review investigation concerning imports of “**Cold Rolled/cold reduced flat steel products of iron or Non-Alloy Steel, or other Alloy Steel, of all width and thickness, not clad, plated or coated**” originating in or exported from China PR, Japan, Korea RP and Ukraine was initiated on 31.03.2021 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules “*The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing*”.

2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, Designated Authority has scheduled an oral hearing in the matter through NIC WEB-EX to be held on **02-08-2021** from **2.30 PM to 5.00 PM**.
